What is the purpose of this update?

This document tells you how the AMP Capital Global Shares Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. AMP Investment Management (N.Z.) Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The fund invests in international shares listed on share markets around the world by using investment managers from around the world which are combined in a multi-manager fund.

Environmental, Social and Governance characteristics are integrated into the underlying investment managers' investment processes, where applicable.

Investments are spread across a range of international share markets, including developed and emerging economies. The portfolio is further diversified by region, manager and investment approach with the aim of delivering more stable returns.

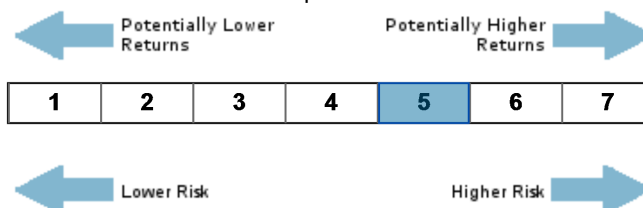
The fund targets a position of being 69% gross hedged to the New Zealand dollar. The hedges are based on the currency components of the underlying index.

The performance objective of the fund is to provide a Gross Return (see note 1 below) above the return of the MSCI All Country World ex Tobacco Index with net dividends reinvested (69% gross hedged to the New Zealand dollar) on a rolling three year basis.

What are the risks of investing?

Risk indicator for the AMP Capital Global Shares Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

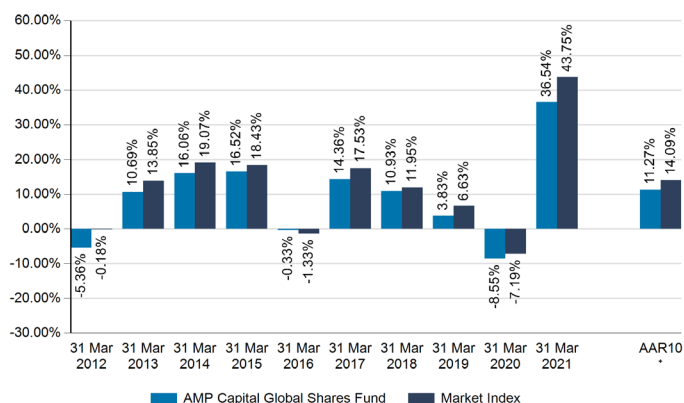

How has the fund performed?

What fees are investors charged?

*The performance fees paid or rebated vary from year to year depending on the outperformance of the underlying funds. The fees in the PDS are based on investment managers' average positive outperformance over the last five years. However, the performance fees in this fund update are based on actual fees paid (or rebated) for the year to 31 March 2021.

Example of how this applies to an investor⁴

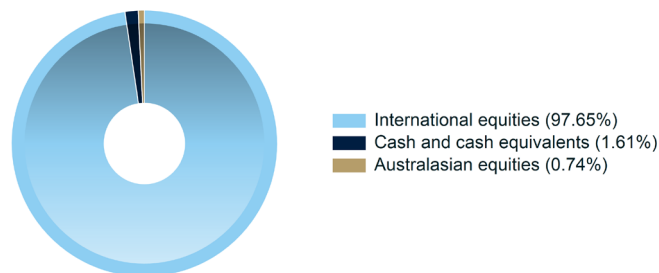
Small differences in fees and charges can have a big impact on your investment over the long term.

Jeff had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jeff received a return after fund charges were deducted of \$4,138 (that is 41.38% of his initial \$10,000). This gives Jeff a total return after tax of \$3,654 for the year.

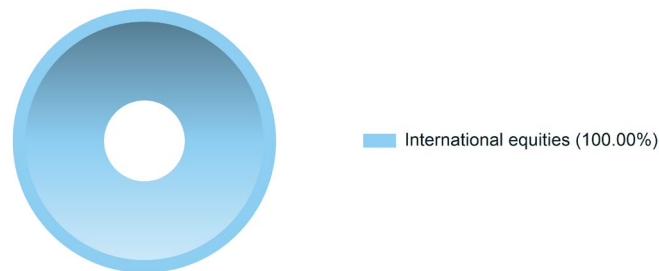
What does the fund invest in?
