What is the purpose of this update?

This document tells you how the AMP Capital Australian Shares Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. AMP Investment Management (N.Z.) Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The fund is a diversified portfolio of Australian shares across a range of industries and sectors.

The fund invests in shares listed, or about to be listed, on the Australian Securities Exchange, through investment in the AMP Capital Equity Fund, a unit trust managed by AMP Capital Australia. The investments of the AMP Capital Equity Fund are diversified across a range of industries and sectors, with a focus on the largest 200 companies. In constructing the portfolio, AMP Capital Australia employ a systematic rules-based approach.

Environmental, Social and Governance characteristics are integrated into the underlying investment manager's investment process.

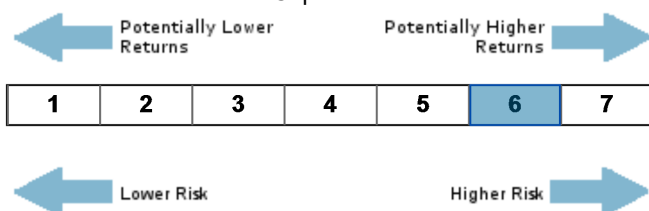
The base position is for the Australian dollar exposure to be unhedged.

The performance objective of the fund is to provide a Gross Return (see note 1 below) above the return of the S&P/ASX 200 Accumulation Index (in NZD) on a rolling three year basis.

What are the risks of investing?

Risk indicator for the AMP Capital Australian Shares Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

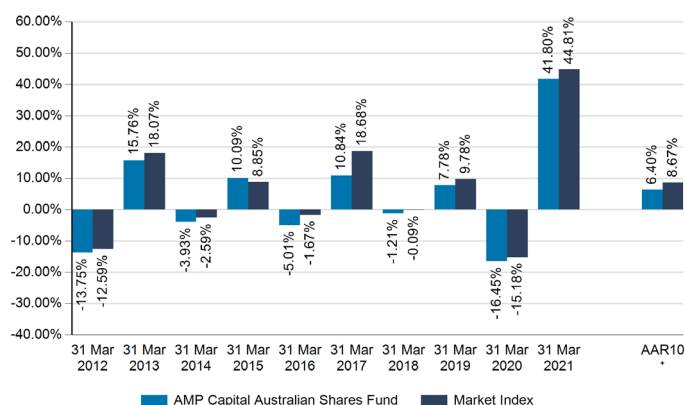

How has the fund performed?

What fees are investors charged?

Investors in the AMP Capital Australian Shares Fund are charged fund charges. In the year to 31 March 2021 these were:

Example of how this applies to an investor⁴

Small differences in fees and charges can have a big impact on your investment over the long term.

Jeff had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jeff received a return after fund charges were deducted of \$4,359 (that is 43.59% of his initial \$10,000). This gives Jeff a total return after tax of \$4,180 for the year.

Notes

1. Gross Return is the return before the deduction of tax, expenses and fees and assumes all income is reinvested.
2. These returns are for the periods ending 30 September 2021.
3. The bar chart shows fund returns after the deduction of fees and tax, however, the market index returns are shown before any fees or tax are deducted.
4. The returns and tax calculations used in this example are the actual fund returns and tax charges (or rebates) for the year ended 31 March 2021. Net of tax returns can be more than gross of tax returns where, due to the fund's tax position, it receives a tax rebate rather than paying tax.
