

Fund update

Mercer Macquarie Real Return Opportunities Fund Mercer Investment Funds

Quarter ending 30 September 2023

This fund update was first made publicly available on: 30 October 2023.

What is the purpose of this update?

This document tells you how the Mercer Macquarie Real Return Opportunities Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Mercer (N.Z.) Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The fund is a diversified fund that aims to generate a positive return above inflation and to actively respond to changing market conditions with a flexible approach to investing. Environmental, Social and Governance characteristics are integrated into the underlying investment managers' investment processes. The fund aims to provide a Real Return of greater than 4% per annum over a rolling five year period.

What are the risks of investing?

Risk indicator for the Mercer Macquarie Real Return Opportunities Fund¹:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.



Example of how this applies to an investor


Ben had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Ben incurred a loss after fund charges were deducted of -\$16.00 (that is -0.16% of his initial \$10,000). Ben also paid \$0.00 in other charges. This gives Ben a total loss after tax of -\$16.00 for the year.



What does the fund invest in?


Actual investment mix

Currency management

The Australian dollar exposure of the fund (the combined market value of the underlying funds) is hedged back to New Zealand dollars. Within the underlying funds, the investment managers actively manage any non-Australian dollar exposures and have discretion as to the amount of non-Australian dollar exposures that may be held.
