

# Fund update

## Mercer Macquarie Real Return Opportunities Fund<sup>1</sup> Mercer Investment Funds

### Quarter ending 31 March 2023

This fund update was first made publicly available on: 3 May 2023.

### What is the purpose of this update?

This document tells you how the Mercer Macquarie Real Return Opportunities Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Mercer (N.Z.) Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

### Description of this fund

The fund is a diversified fund that aims to generate a positive return above inflation and to actively respond to changing market conditions with a flexible approach to investing. The fund aims to provide a Real Return of greater than 4% per annum over a rolling five year period.

### What are the risks of investing?

#### Risk indicator for the Mercer Macquarie Real Return Opportunities Fund<sup>2,3</sup>:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

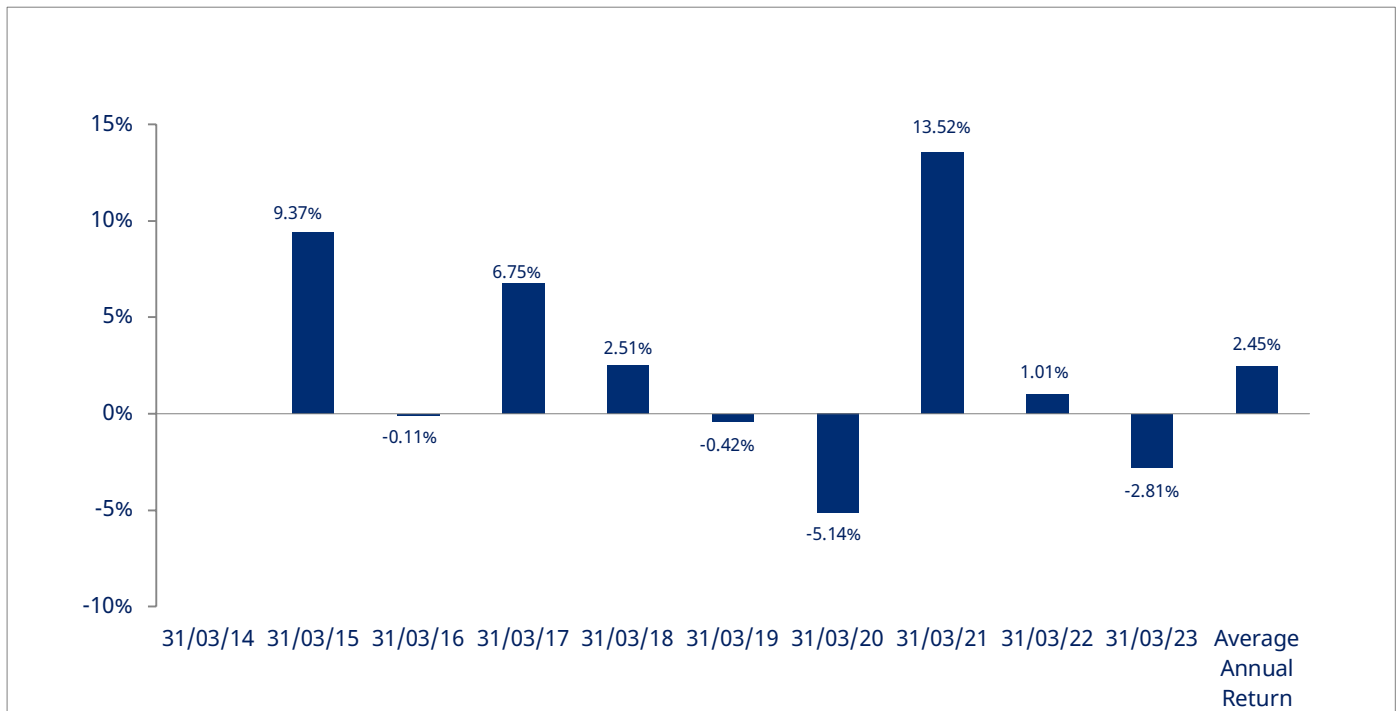

### Annual Return Graph<sup>6</sup>



This shows the return after fund charges and tax for each year ending 31 March since the fund started. The last bar shows the average annual return since the fund started, up to 31 March 2023.

## What fees are investors charged?

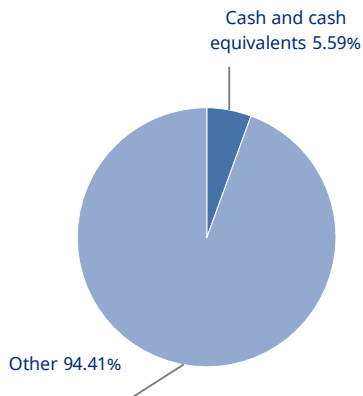
### Example of how this applies to an investor <sup>8</sup>

Ben had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Ben incurred a loss after fund charges were deducted of -\$281.00 (that is -2.81% of his initial \$10,000). Ben also paid \$0.00 in other charges. This gives Ben a total loss after tax of -\$281.00 for the year.

## What does the fund invest in?

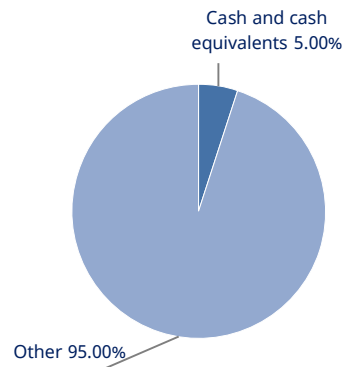
### Actual investment mix

The top 10 investments make up 95.62% of the fund.

### Currency management

The Australian dollar exposure of the fund (the combined market value of the underlying funds) is hedged back to New Zealand dollars. Within the underlying funds, the investment managers actively manage any non-Australian dollar exposures and have discretion as to the amount of non-Australian dollar exposures that may be held. Hedging coverage, on a net of tax basis, for the Fund's exposure to foreign currency as at 31 March 2023 was 101.40%.

## Notes

1. On 3<sup>rd</sup> March 2023, Mercer (N.Z.) Ltd became the manager of the fund. The previous manager was Macquarie Asset Management Public Investments (NZ) Limited. From 3<sup>rd</sup> March 2023, the Macquarie Real Return Opportunities Fund is called the Mercer Macquarie Real Return Opportunities Fund.
2. The expected volatility of the Mercer Macquarie Real Return Opportunities Fund has been calculated by reference to the expected volatility of the underlying funds into which it invests.
3. In previous quarters, the risk indicator has been calculated based on the weekly returns of the Fund. The basis of the risk indicator has changed to the monthly returns to be consistent with other investment options managed by Mercer (N.Z.) Ltd.
4. There is no appropriate market index or suitable peer group index or indices for the fund against which to assess either movements in the market in relation to the returns from the assets in which the fund invests, or the performance of the fund as a whole.
5. These returns are for the periods ending 31 March 2023.
6. The bar graph shows fund returns after the deduction of fees and tax, however, the market index returns are shown before any fees or tax are deducted.
7. GST is currently charged at 15% on 10% of the management fee in accordance with the non-binding IRD agreement with the Financial Services Council of New Zealand Incorporated on behalf of the funds management industry. GST on management fees is currently under review and therefore this percentage may change in the future.
8. The returns and tax calculations used in this example are the actual fund returns and tax charges (or rebates) for the year ended 31 March 2023. Net of tax returns can be more than gross of tax returns where, due to the fund's tax position, it receives a tax rebate rather than paying tax.
