What is the purpose of this update?

This document tells you how the AMP Capital NZ Shares Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. AMP Investment Management (N.Z.) Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The fund is a diversified portfolio of New Zealand shares with the scope to hold Australian shares. The investment approach is research driven and involves determining financial forecasts of companies. The results of these forecasts are then compared against each company's current share price. The investment manager looks for companies which have a sustainable competitive advantage, good growth outlook and the ability to grow earnings.

Environmental, Social and Governance characteristics are integrated into the underlying investment manager's investment process.

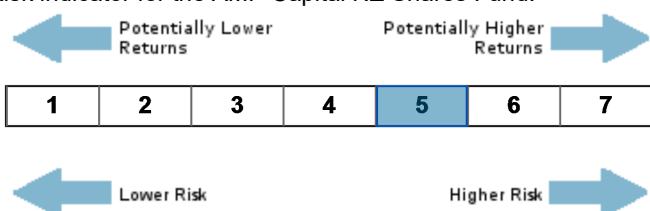
The base position is for the Australian dollar exposure to be unhedged.

The performance objective of the fund is to provide a Gross Return (see note 1 below) above the return of the S&P/NZX 50 Index (on a gross basis and including imputation credits) over a rolling three year period.

What are the risks of investing?

Risk indicator for the AMP Capital NZ Shares Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

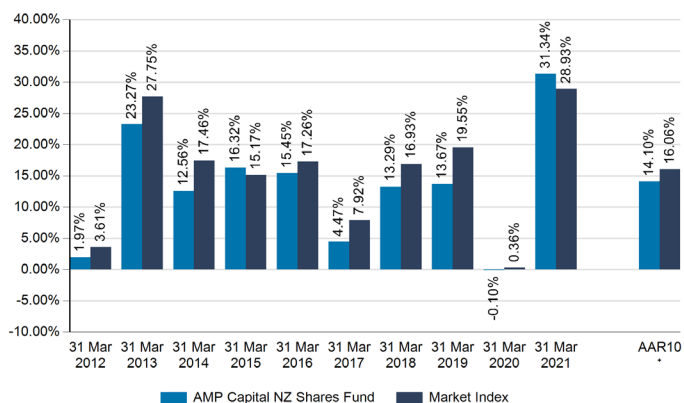

How has the fund performed?

What fees are investors charged?

Investors in the AMP Capital NZ Shares Fund are charged fund charges. In the year to 31 March 2021 these were:

Example of how this applies to an investor⁴

Small differences in fees and charges can have a big impact on your investment over the long term.

Jeff had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Jeff received a return after fund charges were deducted of \$3,199 (that is 31.99% of his initial \$10,000). This gives Jeff a total return after tax of \$3,134 for the year.

Notes
